12/01. Apologies for Absence

Apologies were received and accepted from **Cllr Redfern, Cllr Hall** and **Cllr Mughal**.

UTT/2013/11/FUL. Proposed erection of two new dwellings

Location. Land Adjacent to Carmel Street Chapel, Carmel Street, Great Chesterford

Refused: The development, by reason of the number, siting and size of dwellings, would result in the overdevelopment of the site. The limited private amenity space and inadequate parking provision would result in development that would adversely affect the residential amenities of future occupiers of the dwellings and would be harmful to highway safety through additional inappropriate parking causing obstruction and hazard to other road users, thereby undermining the principle of seeking to discourage on street parking in the locality. The proposal would therefore be contrary to policies GEN1, GEN2 and GEN8 of the Uttlesford Local Plan 2005 which require adequate parking provision for new development, for development to maintain road safety and that development provides an environment which meets the needs of all potential users.
